2019 CNM USBC 14th Men's Invitational Tournament Rules

All USBC Rules apply except as modified herein

1. Tournament is open to all USBC certified male members. Any man who wishes to participate and who does not have a current USBC membership may pay a \$5 participation fee. **Out of country** participants must pay a participation fee of \$5.00.
2. Reserved entries close at midnight May 24, 2019 and must be postmarked no later than May 25, 2019. Entries close 15 minutes before squad time unless the squad is full. Bowlers may enter All Events at any time prior to the start of their first series. Payment must accompany completed entry form.
3. Entering average precedence: (A) Highest 2017-2018 winter book average of 21 games or more. (B) Highest 2018 summer book average of 21 games or more. (C) Highest average as of May 1, 2019 of 21 games or more. (D) A bowler who does not have an average in accordance with A, B or C above must use a scratch average of 220 (Rule 319b). **Bowlers must use their highest inter-association average.** Rule 319-a-2 will apply. Rule 319-a-3 will apply. Rule 319-d & 319-e are waived. Tournament management reserves the right to correct any averages and adjust final tournament standings accordingly. **Bowlers who have established a qualifying average in a sport or sport condition league must use an adjusted average based on the qualifying sport or sport condition average (failure to comply will result in disqualification).** **HANDICAP: 90% of 220 FOR SINGLES/440 FOR DOUBLES/880 FOR TEAM.** **NON-LOCAL ENTRANTS: Averages MUST be verified by local association manager or entry will be returned.** **NOTE:** Local Association Yearbook may be furnished in lieu of this requirement (rule 319-a-5)
4. Prize money paid into each event will be returned 100% to the winners in that event. Prize ratio: at least 1 in 6 including all events, handicap and scratch. Entry fee of \$30.00 per event is divided as follows: prize fund \$17.50, lineage \$9.00 and expenses \$3.50. All Events entry fees are \$6.00 for handicap and \$6.00 for scratch (Rule 309).
5. If a bowler participates in either doubles or singles, they must participate in both. A bowler may cash only once in Singles and only once with the same Doubles partner. Not more than 2 players on a team may cash together (Rule 315). **THE FIRST SCORES FOR EACH EVENT WILL BE USED FOR ALL EVENTS.**
6. **NO MORE THAN 2 PROFESSIONAL BOWLERS ON A TEAM. ONLY 1 PROFESSIONAL BOWLER PER DOUBLES PAIR. (Defined as current member of PBA, PWBA or Senior PBA.) Professional bowlers MUST mark on the entry that they are a professional bowler.**
7. Entries will be scheduled ON A FIRST COME FIRST SERVED BASIS. Tournament Management may make changes in scheduling if necessary. Rule 314 will apply. Tournament Management will assign lanes. **Lineup shall be the same as shown on the entry form.**
8. Any protest involving eligibility or general playing rules must be confirmed in writing to a tournament or local association official or USBC in accordance with rule 329a. Errors in scoring must be reported to Tournament Management within 24 hours of completion of bowling. All decisions of Tournament Management are final unless an appeal is made in accordance with Rule 329b.
9. **RETURNED CHECK FEE IS \$30.00 AND MUST BE PAID PRIOR TO YOUR SCHEDULED SQUAD TIME.**
10. **ENTRANTS ARE EXPECTED TO WEAR SUITABLE ATTIRE WHEN PARTICIPATING IN THE TOURNAMENT** (except for medical reasons). Short sleeved shirts, walking shorts or slacks are preferred. **UNSUITABLE ATTIRE:** Tank tops* Workout Attire (e.g. – Spandex, Sweat pants)* Short Shorts* (if a bowler's fingers are below the hemline, the shorts are considered too short and not suitable)* Bib Overalls* Torn or Unclean Jeans* Shirts/T-shirts with offensive language/pictures* Hats*. **VIOLATIONS:** Entrants will be required to change to suitable attire. Entrants who refuse to wear suitable attire will not be allowed to bowl. **TOURNAMENT MANAGEMENT reserves the right to refuse participation to anyone deemed to be inappropriately attired without recourse. Inappropriate behavior while participating in the tournament will be considered grounds for disqualification.**
11. Electronic devices (video games, radios, CD players, I-PODS etc.) are not permitted during competition.
12. **All squads start promptly. Rule 322 & 323 apply entirely.** **TEAM CAPTAINS:** Check in and report substitutions at least 30 minutes prior to your scheduled squad time.
13. **The lane condition for this tournament is House Pattern.**
